STRAIGHT SHOT FROM THE PRESIDENT

Hello everyone,

I would like to start out by thanking several members for recent accomplishments at the range.

Warren Brader organized a crew to take down the old barbed wire fencing along with other obstacles. I don't have all the names but I will mention those who I am sure of. They were Ira Bryant, Bud Smith, Harry Fagen to name a few. Also, Harry Fagen and Ira Bryant, took advantage of my wood splitter and split all the wood generated when we cleaned out the dead trees where we will have the potential 200 yard rifle range and new fence. I addressed this with the Real Property Manager and she agreed that it should be cleaned out.

The water pump failed last week and a group of people rallied to help me out in replacing it. Warren Brader, Warren Hill, Lonnie Fowler, Delyn Elrod, and others helped remove the old roof on the well house so the new system could be installed. Johnson Pump, responded to our urgent request and installed the new system right away.

Now let us address some issues coming up. You will notice following this message is a list of changes to our bylaws. **These changes will be voted on at the April General Meeting! The Board of Directors has already voted on these changes and we need your support! These changes are necessary to protect ourselves and to avoid the disturbances like we faced most recently! So, be at the General Meeting in April, and support your President and the Board of Directors.**

Also, in the near future you will be receiving a letter from the board in the mail. The purpose of this letter is to change Article V, Section 13 of the bylaws to stipulate that the New Range Fund will change to Range Improvement Fund. The board has voted on the changes in this Article so we can fund the Range Improvements. The Advisory Committee, separate from the Board, have already met and have started to prioritize those improvements keeping safety in mind as the top priority. The distribution of the funds for this will be controlled and explained to you when you receive the letter. Please be patient on this matter until you read the letter. The bylaws require a mail in vote of the membership for this. I am looking to appoint a committee chair to implement this action.

Remember, we have worked long and hard to acquire this new 30 year lease. In order to achieve this, we committed to implement improvements.

I would like to close by asking that you attend the next two general membership meetings and support your Board of Directors regarding these bylaw changes and the election of officers.

**AMENDMENT OF BYLAWS
ESCONDIDO FISH AND GAME ASSOCIATION**

WHEREAS, the Board of Directors of the Escondido Fish and Game Association, a California nonprofit corporation (the "Association") has determined in good faith that it is in the best interests of the Association to amend the Association's Constitution and Bylaws as follows:

1. to require that candidates for the offices of Officer and Director must be members in good standing of the Association and the National Rifle Association for at least one (1) year before their nomination;
2. to require that candidates for the office of President, Vice President, Secretary and Treasurer of the Association to have served at least one (1) term as either an Officer or a Director of the Association and must be members in good standing of both the Association and the National Rifle Association for at least one (1) year before their nomination;
3. to change the office of Treasurer of the Association from a position elected by the membership to a position appointed by a majority vote of the Board of Directors, to insure that candidates for the position have adequate background and experience to competently handle the responsibilities of the office;
4. to establish that if an Officer or Director of the Association resigns from his or her position (including a resignation as a result of two consecutive unexcused absences from Board meetings), that member is prohibited from serving as an Officer or Director of the Association for a period of three (3) years from the date of the member's resignation;
5. to amend Article III, Section 13 of the Association's Constitution and Bylaws to provide that when an individual's membership is terminated for just cause by a two-thirds majority action of the Board of Directors, that individual is ineligible from ever again becoming a member of the corporation; and
6. to amend Article IV, Section 4 of the Association's Constitution and Bylaws to clarify that Robert's Rules of Order shall serve as guidelines for parliamentary procedure for the Association.

RESOLVED: Article III, section 13 of the Constitution and Bylaws of the Association is repealed in its entirety and the following language is adopted in its place:
Section 13 Expulsions/Termination

Any member may be expelled or terminated for just cause by a two-thirds (2/3) majority action of the Board of Directors in accordance with existing laws applicable to nonprofit organizations. Any expulsion or termination must be done in good faith, and in a fair and reasonable manner. Prior to the

expulsion or termination, the members shall be:

- (a) notified of the potential expulsion/termination and the reasons for the potential expulsion/termination fifteen (15) days before the effective date of the proposed expulsion/termination. Notice shall be provided via certified mail and sent to the last address of the member as shown in club records; and
- (b) provided with an opportunity to express his or her position, orally or in writing, not less than five (5) days before the effective date of the proposed expulsion/termination.

Any individual whose membership is terminated for just cause shall be permanently ineligible for membership in the Association.

RESOLVED: Article IV, section 4 of the Association's Constitution and Bylaws is repealed in its entirety and the following language is adopted in its place:
Section 4 – Meeting Procedures

Robert's Rules of Order shall serve as guidelines for parliamentary procedure for the Association.

RESOLVED: Article V, sections 1, 2, and 3 of the Association's Constitution and Bylaws are repealed in their entirety, and the following language is adopted in their place:
Article V Board of Directors

Section 1 – Composition and Qualifications

The Board of Directors shall be comprised of the President, Vice President, Secretary, Treasurer, and six (6) members who meet the following qualifications:

- (a) Qualifications for Director: a candidate for the position of Director must be a member in good standing in the Association and in the National Rifle Association for the period of at least one (1) year immediately prior to the date of the member's nomination. Further, the member must not have resigned from a Director position or an Officer position with the Association within the prior three (3) years before the member's nomination;
- (b) Qualifications for the positions of President, Vice President, and Secretary: to qualify as a candidate for

the positions of President, Vice President, or Secretary, must have served at least one (1) full term as either an Officer or a Director of the Association, and must be a member in good standing in both the Association and the National Rifle Association for the period of at least one (1) year immediately prior to the date of the member's nomination. Further, the member must not have resigned from a Director position or an Officer position with the Association within the prior three (3) years before the member's nomination.

(c) Qualifications for the position of Treasurer: the Board of Directors, or a committee appointed by the Board, shall identify candidates for the position of Treasurer who, in the Board's judgment, possess the necessary education, background and experience to fulfill the demands of the office. The Board has the discretion to appoint a non-member to the position of Treasurer, or to retain a non-member to fulfill the position.

Section 2 – Officers

(a) Elected positions: The positions of President, Vice President, and Secretary shall be elected by a majority vote of the members in good standing present at the election meeting.

(b) Treasurer: The Treasurer shall be appointed by a majority vote of the Board of Directors to ensure that candidates have sufficient experience and background to competently handle the responsibilities of the office.

(c) Terms of Office for President, Vice President and Secretary: The President, Vice President, and Secretary, shall hold office for one year, or when elected or appointed to fill a vacancy for an unexpired term, until his/her successor is elected or appointed.

(d) Term of Office for Treasurer: The Treasurer shall serve at the pleasure of the Board, subject to the rights, if any, of the Treasurer under any contract of retention or employment.

(e) Resignation by Unexcused Absences: If an Officer is absent from two consecutive Board Meetings without being excused by the President or, in his/her absence the Vice President, it shall be deemed that the member has resigned his/her position and the Board will fill the Officer position in accordance with the provisions of Section 6 of this Article.

(f) Effect of Resignation: If a member resigns from an Officer position with the Association, the member is prohibited from holding an Officer position or a Director position for a period of three years from the date of the member's resignation.

Section 3 – Directors

(a) Terms of Office/Election: The six (6) Directors on the Board shall be elected for a term of two (2) years with three members being elected each year. Directors shall be elected by a majority vote of the members in good standing present at the election meeting.

(b) Resignation by Unexcused Absence: If a Director is absent from two consecutive Board Meetings without being excused by the President or, in his/her absence the Vice President, it shall be deemed that the member has resigned his/her position and the Board will fill the Director position in accordance with the provisions of Section 6 of this Article.

(c) Effect of Resignation: If a member resigns from a Director position with the Association, the member is prohibited from holding a Director position or an Officer position for a period of three years from the date of the member's resignation.

RESOLVED: Article IX of the Association's Constitution and Bylaws is repealed in its entirety and following language is adopted in its place:
ARTICLE IX Nominating Committee and Election of President,
Vice President and Secretary

Section 1 – Nominating Committee

At the regular March meeting, the President shall appoint a Nominating Committee consisting of at least three (3) members, and if possible, the majority shall be past Presidents of the Association. The duties of this committee shall be to make nominations and to prepare a ballot for the election of President, Vice President and Secretary to serve for one-year terms in accordance with Article V, Section 2 (c), and for three (3) Directors to serve two-year terms in accordance with Article V, Section 3 (a).

Section 2 – Nominees

At the regular April meeting, the Nominating Committee shall submit its list of nominees, not in excess of two (2) in number for each office to be filled, and its list of nominees not exceeding the number of Directors to be elected plus two (2). Nominations from the floor at the regular April and May meetings may be made for the offices of President, Vice President, Secretary, or Director, and when so made together with the list submitted by the Nominating Committee, shall be the list of nominees submitted to the members for the election of Officers and Directors.

Section 3 – Re-Opening Nomination

At the regular May meeting, nominations will be re-opened for the offices of President, Vice President, Secretary and Director. The balloting and the election of the President, Vice President, Secretary and the three Directors positions shall immediately follow closure of the nominating process.

Section 4 – Annual Meeting and Installation of Officers and Directors

The June meeting shall be the annual meeting and include the installation of the new President, Vice President, Secretary and Directors who will take office at the July Board meeting.

ARTICLE III EXISTING

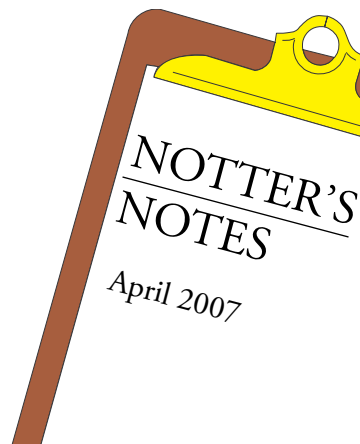

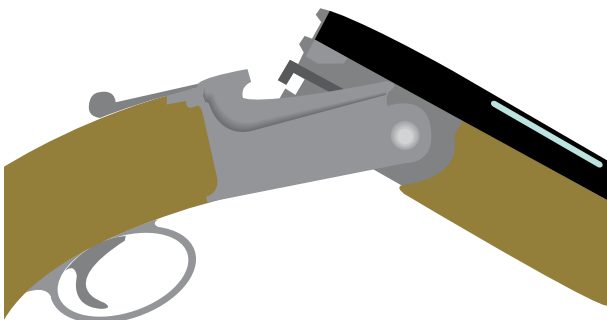
