### PRESIDENT'S VIEWPOINT

Hi Everyone,

I was wondering what to write in my message this month but the events that happened yesterday solved that problem.

At approximately 11:00 am yesterday, July 13, a fire started on the bank just beyond and to the right of the 100 yard range. There were four shooters on that range and two of them witnessed what caused the fire. It was not caused by any of the shooters on the range. I cannot elaborate on this because I am working with the investigator who is conducting the investigation.

Tom Arendall was on the 150 yard range and quickly called the fire department. They were there within 20 minutes. The fire burned about 3 acres of weeds and brush. I arrived on the scene at approximately 11:30. I communicated with the fire chief from the Deer Springs Station immediately and requested to be part of the investigation when the officer arrived. I was granted that request.

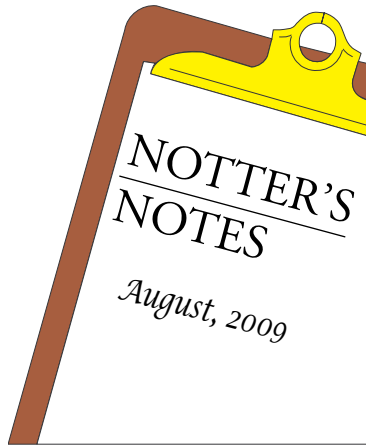
Later that day, I received a call from Jason Rouch, who is the deputy fire chief assigned to fire prevention for the City of Escondido. He was instructed by the Real Property Manager, Ann Margerelle, to meet with me and see if there are things that the City can do to help with our situation. We met today and went around the entire range. Bud Smith and Lonnie Fowler joined me. He was quite impressed with how neat things were. However, he is going to send some crews out, at no cost to us, and do some serious brush cleaning and tree trimming at the end of all the shooting ranges as well as mowing the grass in the field next to the 150 yard range.

This will take about three days. I suggested Wednesday, Thursday, and Friday which we will determine when as soon as possible. This will not affect Wednesday night trap except that they leave at 5:00pm and we can start trap a little later. This work will be done at no charge to us. I think we can all agree that we can sacrifice a little casual shooting and allow them to do this work.

We were very lucky that we had shooters and a range master that were alert when this happened. It should make you realize how important it is to use only lead bullets on our range. I would also like to thank all those that responded to my calls during this unfortunate event.

# R A N G E M A S T E R S O U N D O F F

Members and Range Officers,

What is the role of the (RSO) Range Safety Officer? The RSO supervises shooting activities as prescribed by the range SOPs (standard operating procedure). It is the RSO duty to maintain order on the range. The RSO ensures that the shooters follow the range regulations which prevent possible property damage and personal injury. We are in critical need of more Range Officers.

I've updated our active RSO list and the numbers are not acceptable to support range safety. We have 39 Active Officers. Active RSO's are those volunteering one 5 hour shift a month. Many of the 39 are working 4+ shifts monthly. 39 Range Officers cannot cover all our ranges. We also have 21 members that are Class Instructors, Shoot Chairs and Trap Masters. They run their events but not all stand Range Master shifts. You can't run a shoot and be in charge of the entire range at the same time, it doesn't work. I thank the entire group for the time they donate to this association. Please attempt to recruit Range Officers from your individual shoots. We have a membership of 1400+ individuals with less than 75 doing all the work. We cannot continue to run a safe range without more member participation. With over 1400 members to draw from one would hope to reach my goal of 100+ Range Officers, unfortunately it hasn't been in the cards. We need at least 60 more new Range Officers.

**This is the reality!!** Many ranges in San Diego will not allow members to shoot on any range without an RSO on duty. If an RSO is not present that range is CLOSED. In our case we have a pistol range, trap range, and two rifle ranges. Do the math, 4 range officers twice a day to cover all the ranges. The county is in the process of writing new regulations for all SD County Ranges and we need to be prepared in numbers with a strong volunteer RSO Team. I've asked for help many times in the past two years with limited response. **If the rules change, we might find our ranges closed for the day because we don't have enough personnel to meet the requirements.** This is your association. Make a commitment and volunteer for a position of Range Officer. Please commit to a minimum of one or more shifts per month. We will train and certify you. We have a number of trainer's available during the week and weekends. The Trainers are: Bud Smith, Tom Kendall, Lee Allen, Bob Ware, Jay Zimmitt, Tom Arendell and Harry Fagan. We now have Two Assistant CRSO's. Lee Allen and Tom Kendall are the point CRSO's to call to schedule a training day. Tom accepted the position of Assistant CRSO last month and Lee Allen was appointed Assistant CRSO in this month. All you need is the desire to help and a good attitude. Frank and I will be planning another RSO Class Sunday Sept 6th, email me now to reserve your spot. Don't wait to volunteer, you do not need to be a Certified RSO to be a Range Officer, however I highly suggest you sign up for the next RSO class. The majority of our Range Officers are Certified NRA RSO.

Range News. In the past two years I have witnessed a number of incidents on the range and most have a common denominator; **RELOADED AMMUNITION.** Today's high cost and inconsistent availability of ammo has driven many shooters to reloading their own ammo. While reloading can be done safely, one needs to remember it requires knowledge, skill, education, examination and precision. NEVER shoot reloaded ammo from a person you do not know. A good rule of thumb is to shoot only factory ammo or factory reloads or those you reloaded yourself. Never exceed the maximum powder charge that is listed in a reloading manual. Only use data that is published by a bullet or powder manufacturer. Always inspect your unloaded cases before you start the process, during, and again in the final stages. Read the charts, take a class, and learn the skill. Reloading is a process that demands exactness and precision. Do not deviate from the recommended recipe. The incorrect powder load may destroy your firearm and cause bodily injury, even death.

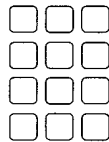

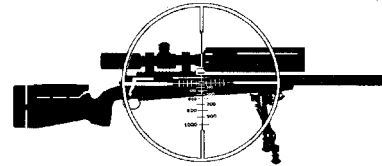
