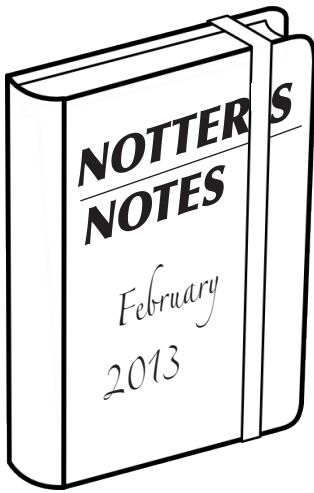

### NRA METALLIC COURSE CARTRIDGE RELOADING

Have you wanted to reload but didn't know where to start? The opportunity to learn how to reload is available Saturday, February 9th, 2013 and Saturday, April 6th, 2013 at the EF&GA meeting hall. This course is a certified NRA reloading course (not sponsored by EF&GA). The NRA Metallic Cartridge Reloading Course will be conducted by Elvio Marchi, an NRA certified instructor. This NRA course will require that all students prove their proficiency with a "hands on" session for certification. In order to provide the accessibility to equipment necessary to accomplish this, the class will be divided into two segments. The academic portion will be held at the meeting hall on the range from 8:00 A.M. to Noon, but due to equipment logistics, the hands on portion will be held at a separate location on an agreed upon day and hour. The class will be split into smaller groups to facilitate instruction of the "hands on" portion. This portion will be essential to completion of the course...certification cannot be issued without it. The fee will be \$65 (\$80 for individuals w/o supplies) for those individuals that have their own supplies (cases, powder, primers, projectiles and dies). Various caliber dies are available for use...check with Elvio on caliber availability. A non-refundable \$20 deposit will be required prior to registration. Class size is limited to 10 individuals. # CALIFORNIA LEGISLATIVE NEWS

The legislature reconvened on January 7 to begin the first year of the 2013-2014 legislative session. The new legislature was sworn in on December 3. As of December 20, there were already three anti-gun bills introduced: AB 48, SB 47, and SB 53. It is early in the session, and it is likely that the language in these bills may be amended over the next few weeks.

## **AB 48**

### **Firearms: ammunition: sales (Skinner, D-Berkeley)**

**Purpose of Legislation:** This bill would make it a misdemeanor to knowingly manufacture, import, keep for sale, offer or expose for sale, or give or lend any device that is capable of converting an ammunition feeding device into a large-capacity magazine. The bill would revise the definition of "large-capacity magazine" to mean any ammunition feeding device with the capacity to accept more than 10 rounds, including a readily restorable, as defined, disassembled large-capacity magazine, and an oversize magazine body that appears to hold in excess of 10 rounds. This bill would also restrict ammunition purchases and require all ammunition purchases to be reported to the California Dept. of Justice. Purchase of unspecified amounts of ammunition, within a five-day period, would be required to be reported to local law enforcement by the Department of Justice, and ammunition vendors would be required to be an authorized firearms dealer. This bill does not apply to the possession of a readily restorable disassembled large-capacity magazine or an oversize magazine body that has been permanently altered so that the magazine cannot accommodate more than 10 rounds by a person who lawfully possessed the magazine prior to January 1, 2014. This bill contains other related provisions.

CRPA's position: Oppose - Current Status: May be heard on or after 1/20/13

## **SB 47**

### **(Yee, D-San Francisco)**

**Purpose of Legislation:** This is a spot bill that will have language added by the author at a later date. Currently the bill states that it is the intent of the Legislature to enact legislation relating to assault weapons.

CRPA's position: Watch - Current Status: May be heard on or after 1/18/13

## **SB 53**

### **Ammunition: purchase permits (de Leon, D-Los Angeles)**

**Purpose of Legislation:** The bill would, commencing June 1, 2014, require a permit issued by the California Department of Justice in order to purchase any type of ammunition. Ammunition purchases would be limited to face-to-face transactions. The bill would establish an application process and specify the information to be displayed on the permit. The bill would provide that the permit authorizes the holder to purchase ammunition from an ammunition vendor. This bill would require the Attorney General to maintain copies of ammunition purchase permits. This bill would also prohibit internet and mail order sales of ammunition. This bill contains other related provisions.

CRPA's position: Oppose - Current Status: May be heard on or after 1/20/13

# RANGEMASTER SOUND OFF

It is time to talk about some of our more fundamental safety rules that many of our new members and some of our longest members are forgetting. For many years, all new members, before receiving their membership credentials, have had to attend the New Member Orientation and Safety Walk-

About. During the safety briefing, all range facilities are visited, the function of each range and the safety rules are discussed. One would think that with the items stressed during the walk-about, that there should not be an issue with range use and safety. One would be wrong. Some of the things to remember, but not all:

- ✓ Members are responsible for knowing, and advising their guest(s), of ALL Administrative and Casual Shooting Rules. Failure to follow the Administrative and Range rules are grounds for temporary or permanent loss of membership privileges.
- ✓ Members are required to have their Association membership card and a picture ID or the new photo proximity card, in their possession at all times while on the range. Any member or Range Safety Officer can ask a person for his/her membership card/photo identification. These must be produced, no exceptions. Membership card displayed via a clear card pouch and lanyard is preferred while at the range.
- ✓ Only two guests per member. To bring more than two, contact the Association Secretary (Geoff Orchin). He will forward an e-mail stating the number of guests allowed and copy me. Have the e-mail with you when you visit the range.
- ✓ **Juniors Members**, those shooters 8 through 17
  - must be accompanied by a parent or legal guardian or an adult with a signed permission slip from their parent or legal guardian.
  - may **not** use a rifle, shotgun, handgun or archery **without direct supervision** of a parent or legal guardian or an adult with a signed permission slip from their parent or legal guardian.
  - may **not** bring guests, except for their parent(s) or legal guardian(s) or an adult with a signed permission slip from their parent or legal guardian.
  - the supervising adult, unless an active member of EF&GA in good standing, is **prohibited from shooting**, except for instructional purposes.
  - must stay with their parent(s) or legal guardian(s) at all times, even in the primitive camping area.
- ✓ **Youth Members**, 18 to 21, may **not** be in possession of a handgun unless accompanied by a parent or legal guardian or an adult with a signed permission slip (EF&GA rule). Youth members may shoot rifle, shotgun and archery without a parent or legal guardian. Youth members may bring two guests to the range.
- ✓ Eye and ear protection required for everyone, including spectators, while in a shooting area. Within 25 feet of the firing line is preferred.
- ✓ The Pistol, Rifle, Archery and manual hand trap range(s) are open from 7:00 a.m. to local sunset (sunset at the range). Trap ranges are open Tuesday morning, Wednesday and Saturday afternoon/evenings to close, approximately 9:00 p.m. Trap days are open to members and the public.
- ✓ Sign in first, then unload equipment and firearms only while the range is HOT (HOT is defined as members actively engaged in shooting on that range.) Do not, for any reason, handle any equipment or firearms while a range is COLD (COLD is defined as shooting stopped, firearms down and possibly people down range.)

When bullets or shot shells fail to fire when the firing pin strikes the primer; keep the muzzle pointing down range and keep the action closed. Wait at least 30 seconds or so before removing the bad bullet. Place the bad bullet in one of the red cylinders located on each range. *Please do not throw the bad bullets in the trash, on the ground, in the cigar/cigarette receptacle, or in the brass collection buckets.*
