We have hired a new maintenance man and he is going to work several days in a row to spruce things up for us before the upcoming major events.

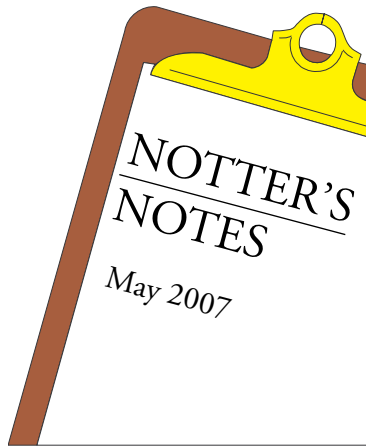
Remember, Rangemasters Appreciation day is April the 29th. All range masters and shoot chairman need to come and have a good time.

TO: ESCONDIDO FISH AND GAME ASSOCIATION, INC.

I hereby acknowledge that at all times hereafter when I enter upon the property and facilities (the "Property") leased, owned and/or operated by the ESCONDIDO FISH AND GAME ASSOCIATION, INC., a California nonprofit corporation (the "Association"), I shall do so voluntarily. I acknowledge that I am aware that the Association is leasing the real property on which the Association's property and facilities are located, from the City of Escondido, a municipal corporation (the "City"). I further acknowledge that I have been advised and am aware that there is a handgun/pistol firing range, a rifle firing range, a shotgun/'trap' shooting range and an archery range (collectively the "Ranges") on the Property, and that arrows and live ammunition are used and discharged on the Ranges. I have read and am familiar with the rules (the "Rules") for the Ranges published by the Association and agree to fully abide by and adhere to the Rules. I represent and warrant to the Association that I have not previously been barred by the Association from using the Ranges. I hereby waive, disclaim and abandon any right I may now have, or hereafter may acquire or have, to bring any action, lawsuit or other proceeding against the Association or the City by reason of any injury I may incur, or as a result of damage to any property I may own or possess, while on the Property, unless such injury or property damage is caused by the gross negligence or willful misconduct of Association or City. Without limiting the generality of the foregoing, I voluntarily assume any and all risks that may be inherent in, exist by reason of, or arise out of the existence of the Ranges on the Property. I further agree to indemnify and hold harmless the Association, the City and their respective successors, assigns, owners, employees, agents, servants, officers, directors, stockholders, shareholders, partners, members, trustees, attorneys, sureties, elected officials and other affiliated personnel (the Association, the City and all such personnel being referred to herein collectively as the "Indemnitees"), from and against any and all liabilities, damages, judgments, costs, fees, expenses, charges, bond premiums, accounting fees, expert fees and attorneys fees, directly or indirectly relating to, or arising out of or by reason of, any act, omission, failure to act, willful misconduct or negligent conduct, whether active or passive, on my part, or on the part of any dependent or guest of mine under the age of 21 years of age, while I or any such dependent or guest is on the Property. I intend to provide the Indemnitees with the broadest possible scope of indemnity and, therefore, I agree that my duty to so indemnify the Indemnitees shall arise regardless of whether willful misconduct or negligence on my part, or on the part of any such dependent or guest, is established, as long as the injury or damage arises out of, or is in any way connected with, my act, omission, or failure to act while I am on the Property. I intend that the Association be the direct recipient and beneficiary of this Agreement and that the other Indemnitees, jointly and severally, be third party beneficiaries of this Agreement. I understand that but for my execution of this Agreement, neither the Association nor the City would allow me or any such dependent or guest to enter upon the Property. This Agreement shall apply on the date hereof and anytime thereafter that I am on the Property. I HAVE READ AND UNDERSTOOD THE TERMS OF THIS AGREEMENT AND AGREE TO BE BOUND BY ITS TERMS.

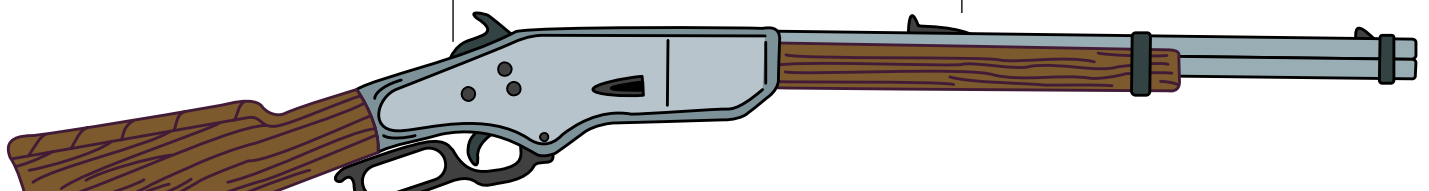

Hello everyone. We just want to take this opportunity to thank all of you who came out and took part in our Friday in March muzzle loading workshops. Due to the continuing interest in these workshops, we have decided to continue them on a limited basis. Starting May 25th, 2007 we will be having the muzzle loading workshop the fourth Friday of each month. (This will give shooters an opportunity to practice before the match on Sunday.)

If you've ever wanted to try your hand at smoke pole shootin', this will be your chance.

Please remember that with the extended hours at this time of the year, the need for Range Masters is crucial. The monthly sign up sheets (green booklet) are kept in the trap Ramada first aid box, (the combination is the same as the gate code). Please help out with a few hours of your time by signing up for duty. The need is greatest during the hours of 5:00 P.M. - Sunset.

The clubhouse has been left open as often as possible for the use of our members during casual shooting hours. Please remember that the janitor is not your personal maid. Please clean up your own mess before you leave.

Many of you have mentioned that there is a lack of target frames. We are in the process of having new ones made and distributed. The new frames are built by one gentlemen and it takes a little time. Thank you in advance for your patience.

Range Masters: We have the ability to order a summer, short sleeve version of our Bob Allen range master shirts. These shirts will only be ordered on a pre-paid basis. These shirts are not supplied by the Association and must be individually ordered. If you are interested, please call Ray or Neil.

The cost of these shirts is 21.00 dollars.

Rifle range users, please remember to park your vehicles in the lot across from the range so as not to block the fire department easement.

Members and/or guests must sign in on the green sheets before unloading your vehicle and equipment. Don't forget you also need to sign out when you leave.

Safety tip for the month: During a cease fire, every person in the area of the range must stay behind the yellow line and may not handle ANY equipment of any kind. This includes the packing or unpacking of firearms, or even the handling of cleaning equipment.
